### 5. YOUR RIGHTS

As personal data owners, if you submit your claims regarding your rights to our Company, our Company will finalize the request free of charge within thirty days at the latest according to the nature of the request. However, if a fee is foreseen by the Personal Data Protection Board, the fee in the tariff determined by our Company will be charged. In this context, personal data owners;

- To learn whether personal data is processed,
- To request related information if personal data is processed,
- To learn the purpose of processing personal data and whether they are used in accordance with their purpose,
- To know the third parties to whom personal data is transferred at home or abroad,
- To request correction of personal data in case of incomplete or incorrect processing and to inform the third parties to whom the personal data are transferred,
- To request the deletion or destruction of personal data in the event that the reasons requiring processing are eliminated, although it has been processed in accordance with the provisions of the PDP Law and other relevant laws,
- To object to the occurrence of a result against the person himself by analyzing the processed data exclusively through automated systems,
- In the event that the personal data is damaged due to unlawful processing, he/she has the right to demand the damages.
